Application process:

- Tournament entry fee \$300.00 per U7-U9 teams, and \$350.00 per U10-U14 teams including Cross Quad and Option 1 teams
- Apply online –
 - Registration Open's on Jan. 11th, 2012
 - Registration Deadline is May 11th, 2012. Any Application received after May 11th must include a **\$50.00 late Fee.**
 - Payment will be accepted by credit card online or by check mailed to the **SoccerFest WITHIN 2 WEEKS** of application:

 - All Tournament Fees will be charged upon application.
 - No team will be scheduled without full payment – **NO** Exceptions
 - Any team not accepted will be notified by e-mail and tournament fees will be refunded.
 - No fee's will be refunded after acceptance via e-mail
 - Only a limited number of teams will be accepted.

Team Selection:

- Team's accepted into the tournament will be based on First received basis.
- Team bracketing will be based on playing level requested – Tournament committee reserves the right to combine playing levels.
- Late entries will be placed on a space availability basis; late fee of \$50.00 will be required.

Other Facts:

- Each team will play a minimum of 3 games
- A Champion will be crowned in each division
- A team trophy will be awarded to Champions
- Individual medallions will be awarded to each player of Championship or Finalist teams
- USSF certified referees
- Communication leading up to the event will be conducted via email, the team coach or manager who registers the team needs to have easy access to email
- Tournament results and standings will be updated on the tournament website each evening during the event.
- Soccer Fest is a restricted tournament sanctioned by the Colorado Youth Soccer Association. All Colorado State Associations member teams, are welcome to apply.
- Mandatory check-in will be held on June 7th, at the North Area Rush Soccer Office located at 3901-A E. 112th Ave. Thornton, CO 80233
- All local teams are required to check in their team on June 7th.
- All players participating in Soccer Fest must have a valid 2010-2011 player pass and medical release.
- Teams may carry up to 3 guest players on the tournament roster. Teams must follow the rules and procedures for guest playing as stated by their own home state association or national affiliate.
